



## TERMS AND CONDITIONS

I acknowledge and understand that the Kalispel Tribe of Indians ("KTI") is a federally recognized, sovereign Indian tribe. I hereby release KTI, its entities, enterprises, officers, agents, employees, volunteers, and assigns from any and all claims, actions, causes of action, demands, rights, damages, costs, expenses, and compensation whatsoever, including the known and unknown, foreseen and unforeseen, that may occur as a result of my participation in the Kalispel Horn Show. I further release and discharge KTI including, but not limited to, its entities, enterprises, officers, and employees, from any and all judgments and/or claims related to my participation in the Kalispel Horn Show from any cause and for any harm or injury whatsoever.

I acknowledge and understand that by entering the Reservation as defined in section 1-2.03 of the Kalispel Tribal Law and Order Code ("KLOC"), I am entering at my own risk, impliedly accept the existing conditions of Reservation lands and activities, and agree to comply with the KLOC.

Further, I authorize KTI including, but not limited to, the Kalispel Casino ("KALC"), to use, copyright, alter, reproduce, and publish my name, image, likeness, and/or voice in electronic or any other form ("materials") without compensation. I also authorize KTI to use these materials for marketing purposes without notifying me of such use. Marketing purposes include, but are not limited to, commercial media (TV, radio, newspaper, magazines, billboards, etc.), social media (Facebook, Twitter, etc.), KTI public and internal websites, and KALC property signage (digital and static). I further understand that materials released pursuant to this Authorization may be subject to re-disclosure and KTI may publish materials, use my name, and/or make reference to me in any manner that KTI deems appropriate in order to promote/publicize KALC endeavors.

I agree that all materials are and shall remain the property of KTI. I understand that this Authorization is continuous and may only be withdrawn by my specific revocation of this Authorization by submitting a written request to KTI. I understand that revocation will not apply in those instances in which KTI has acted upon this Authorization prior to revocation being received by KTI. A copy of this release shall have the same force and effect as the original. I understand that this Authorization shall be binding upon me, my heirs, and assignees.
